

Thank you for enrolling your child in our summer programs. Please read the following terms and conditions: Space is limited in our programs, so there are no refunds once camps are paid, unless we cancel the camp, so please check your summer calendar carefully before enrolling. No refunds for illness, traveling, etc. No siblings or friends can tag along, unless he/she has registered and paid in advance to attend. Parents agree to pick drop their child off no more than 5 minutes to the start of each camp, and no more than 5 minutes after the ending time of each camp. In the event that a camp teacher is unable to teach, a substitute staff member may be used. Any substitutes will at the very minimum hold a bachelor's degree in a related field, AND have documented, successful teaching experience. Students agree to be team-players, using kindness and curiosity throughout their time with us. Safe, responsible and respectful behavior is expected. Waiver: To the full extent permitted by law, the client shall indemnify and hold harmless Rogue Valley Tutoring Center and Rogue Valley Tutoring Center Contractors for any liability resulting from personal injury, property damage, or monetary loss arising out of, resulting from, or caused by the acts or omissions of the client. By signing this contract, the Responsible Party acknowledges all educational costs and any legal costs (if incurred by Rogue Valley Tutoring Center in the fulfillment of this agreement) are his/her responsibility.

**LIABILITY RELEASE WITH PARENTAL CONSENT FOR MEDICAL/EMERGENCY TREATMENT AND TRANSPORTATION** The undersigned(s) being the lawful parent(s) and/or guardian(s) of the above child, hereby consent to the participation by the child in all tutoring activities conducted by Rogue Valley Tutoring Center and to the participation of the child in all events related to said activities. The undersigned hereby further authorize(s) any of the staff, employees, agents and representatives of Rogue Valley Tutoring Center to provide for, approve and authorize any health care at any hospital, emergency room, doctor's office or other institution, employ any physicians, dentists, nurses or other person whose services may be needed for such health care, review and if necessary disclose the contents of any medical records, execute any consent form required by medical, dental or other health authorities incident to the provision of medical, surgical, or dental care to the child. Health care shall include, but not be limited to the administration of anesthesia, x-ray, examination, performance of operations, diagnostic and other procedures. The undersigned(s) hereby further authorize(s) emergency transportation by either school personnel or if necessary by ambulance or other emergency vehicle. If there is no medical emergency, the tutoring staff will first use reasonable efforts to contact the parent(s) and /or guardian(s) before administering or authorizing any treatment. Notwithstanding other provisions in this consent form, Rogue Valley Tutoring Center shall not have the authority to withhold or withdraw life-sustaining procedures for the child. Our Center is well child-proofed and the children are consistently well supervised. However, accidents do happen. The undersigned(s) assume(s) all risk of injury or harm to the child associated with participation in tutoring, camps & special events and agree(s) to release, indemnify, defend and forever discharge Rogue Valley Tutoring Center and it's staff, employees, and agents of and from all liability, claims, demands, damages, costs, expenses, actions and causes of action in respect of death, injury, loss or damage to the child, or by the child, howsoever caused, arising or to arise by reason of or during the child's participation in the tutoring center.
